## **A/A 4-AC™ Phantom Power Supply (AC Powered)**

The A/A 4-AC™ phantom power supply provides +48 volt phantom power for as many as four condenser microphones.

This supply can be plugged into a conventional AC power outlet and incorporates a power on/off switch and associated LED power indicator. The A/A 4-AC utilizes premium XLR connectors with female inputs and male outputs. A ground lift switch is incorporated which will disconnect the incoming or outgoing microphone shields from the internal system ground to minimize hum due to ground loops.

The internal DC supply voltage is isolated from the outputs of the A/A 4-AC to prevent the unwanted DC voltage from getting into the microphone inputs of your mixer.

The A/A 4-AC is housed in a rugged enclosure for optimum convenience and reliability.

NEVER USE CLEAR OR SCOTCH TAPE FOR THESE APPLICATIONS.

1. Read all safety and operating instructions before using this product.

4. All operating instructions should be followed.
5. This product should not be used near water, i.e. a bathtub, sink, swimming pool, wet basement, etc.
6. This product should be located so that its position does not interfere with its proper ventilation. It should not be placed flat against a wall or placed in a built-in enclosure that will impede the flow of cooling air.
7. This product should not be placed near a source of heat such as a stove, radiator or another heat producing amplifier.
8. Connect only to a power supply of the type marked on the unit adjacent to the power supply cord.
9. Never break off the ground pin on the power supply cord. For more information on grounding, write for our free booklet "Shock Hazards and Grounding."
10. Power supply cords should always be handled carefully. Never walk or place equipment on power supply cords. Periodically check cords for cuts or signs of stress especially at the plug and the point where the cord exits the unit.
11. The power supply cord should be unplugged when the unit is to be unused for long periods of time.
12. If this product is to be mounted in an equipment rack, rear support should be provided.
13. Metal parts can be cleaned with a damp rag. The vinyl covering used on some units can be cleaned with a damp rag, or an ammonia based household cleaner if necessary.
14. Care should be taken so that objects do not fall and liquids are not spilled into the unit through the ventilation holes or any other openings.
15. This unit should be checked by a qualified service technician if:
  - A. The power supply cord or plug has been damaged.
  - B. Anything has fallen or been spilled into the unit.
  - C. The unit does not operate correctly.
  - D. The unit has been dropped or the enclosure damaged.
16. The user should not attempt to service this equipment. All service work should be done by a qualified service technician.
